DON'T RELY ON YOUR EMPLOYERS COVERAGE

Many MRT/ENPs believe they are properly covered under their employer's Professional Liability policy, but this is not the case in most situations. Employer's coverage may be inadequate due to varying limits and types of coverage. This could lead to inadequate limits to defend both the employee and the company in the event of a lawsuit. The employer's coverage will not provide coverage to help a MRT/ENP through a complaint or investigation by the regulator.

EXPLANATION OF COVERAGE AVAILABLE

PROFESSIONAL LIABILITY COVERAGE

Covers claims of negligence during your work as a MRT/ENP, including damages from professional services, incorrect care, or failure to provide care. Includes legal expenses for defense.

DISCIPLINARY EXPENSE COVERAGE-INCLUDED

Provides \$100,000 coverage for legal assistance when a complaint leads to an investigation by the regulatory body, supporting MRT/ENPs through the disciplinary process.

GENERAL LIABILITY COVERAGE (OPTIONAL)

General Liability coverage protects MRT/ENPs against claims of bodily injury, property damage, or personal injury that may occur during their professional activities. This policy covers legal defense costs and settlements related to incidents such as slips and falls on premises or damage to a client's property, ensuring comprehensive protection against unforeseen liabilities.
